## 1. Notification

### 1.1 General

The Ministry of Energy and Water of the Republic of Lebanon ("MoEW") plans to expand the installed power generation capacity in Lebanon by large scale conventional power projects and will be releasing Requests for Proposals for Independent Power Producers for the implementation of such projects in the near future.

In order to participate in such tenders as a Lead Developer or a Consortium Member, potential participants shall apply in a first step for classification in line with this Invitation for Classification ("Invitation").

With this Invitation and in accordance with the *Lebanese Law 129/2019, Council of Minister ("CoM") Decision No.1 dated 8/4/2019 and decree 3688/1966*, the Ministry of Energy and Water (MoEW) invites Applicants to classify as Lead Developers or Consortium Members for the design, engineering, construction, financing, testing, commissioning, operation and maintenance of conventional power plant projects as Independent Power Producer ("IPP") and selling the capacity and electrical energy to the MoEW under a long term Power Purchase Agreement ("PPA").

Applicants are invited to state their interest to act as an IPP for upcoming conventional power plant projects in Lebanon by submitting an Application for Classification in the format and contents set out in this Invitation

Applicants may be single firms which have relevant technical experience and sufficient financial standing. Applicants can apply for classification either as a Developer or as a Consortium Member.

### 1.2 Conflict of Interest

An Applicant shall not have a conflict of interest. All Applicants found to have a conflict of interest will not be considered for classification. Applicants may be considered to have a conflict of interest with one or more parties applying for classification under this Invitation, if they:

- have controlling members in common; or
- participate in more than one application in this classification process. Participation by an Applicant in more than one application will result in the disqualification of all applications in which the party is involved; or,
- consist of entities economically intertwined with the MoEW and EDL; or
- other state-controlled enterprises that are not legally or financially independent.

### 1.3 Reasons for Exclusion from Classification

An Applicant will be excluded from classification, if the Applicant

- is bankrupt or being wound up, are having their affairs administered by the courts, have entered into an arrangement with creditors, have suspended business activities, are the subject of proceedings concerning those matters, or are in any analogous situation arising from a similar procedure provided for in national legislation or regulations;

- has been convicted of an offence concerning their professional conduct by a judgment against which no appeal is possible;
- has been guilty of grave professional misconduct proven by any means which the Ministry of Energy and Water can justify;
- it has been the subject of a judgment for fraud, corruption, involvement in a criminal organization or any other illegal activity detrimental to Lebanon's financial interests against which no appeal is possible; and
- is prohibited from doing business with MoEW on grounds which may include but are not limited to public policy or national interest.

#### **1.4 Local Representation**

The Applicant – if a foreign company – is mandatorily required to have representation in Lebanon either in the form of a Lebanese partner, agent, officer or a local affiliate registered to do business in Lebanon subject to the requirements set forth in Form C of Appendix A.

Local Applicants are also required to submit the documents set forth in Form C of Appendix A.

#### **1.5 Subsequent Bid Process**

MoEW will issue an RFP that will include, inter alia, the following information:

- Instructions to Bidders;
- Technical Specifications;
- Technical and Financial Form sheets;
- Technical Drawings & Documents;
- Draft Project Agreements; and

Parties submitting replies to the RFP will be required to submit, inter alia, the following as part of their bid:

- Documents establishing a joint venture / partnership among the members of Classified Consortium;
- Statement of classification by MoEW;
- Official company documents;
- Power of Attorney;
- Relevant technical and financial information;
- Supporting financial information (e.g. intended terms and conditions and support letters from Finance Parties).

**All official documents pertaining to foreign companies shall be duly certified by the Ministry of Foreign Affairs and Emigrants.**

## **2. INSTRUCTIONS TO APPLICANTS**

### **2.1 Application Requirements**

The Applicant must submit the Application documents (1 original, 2 hard copies and 2 copies in electronic form) to the following address:

The Application must be submitted in a sealed envelope (or box) clearly stating the number of the Classification enquiry, the purpose of the Classification as well as the Name of the Applicant.

### **2.2 Submission**

The Application must be received by MoEW at the address specified in section 2.1. MoEW will review and evaluate the application within a period of maximum 4 weeks and will inform the applicant of the evaluation results.

### **2.3 Language**

The Application documents prepared by the Applicant and all accompanying correspondence and documents relating to the Application exchanged by the Applicant and MoEW, shall be written in the **English language**. The Applicant may use the Arabic language to fill forms that are provided in Arabic. Any printed literature furnished by the Applicant as part of its Application may be written in another language as long as it is accompanied by a certified English translation in which case, for the purposes of interpretation of the Application documents, the English translation shall prevail.

### **2.4 Clarifications**

Should an Applicant require clarification on any respect of this Invitation, the Applicant may submit its written enquiry either by hand or by facsimile to MoEW, to the same address as mentioned above in Section 2.1.

Any request for clarification shall be received by MoEW no later than seven (7) Business Days before the Deadline of Submission. Any request for clarification from the Applicant received later than the date above will not be considered.

MoEW will respond to any clarifications at the latest three (3) Business Days prior to the Deadline of Submission.

**2.5 Cost**

The Applicant shall bear all costs and expenses associated with the preparation of its Application for Classification.

**2.6 Disqualification**

MoEW may disqualify or reject an Applicant for Classification for any reason at MoEW's sole discretion, including but not limited to:

- Failure by the Applicant to comply with the requirements of this Invitation;
- Misrepresentation, withholding and concealment of information provided with the Application; and
- Failure to disclose or provide any additional information as may be required MoEW for classification; and
- If any of the reasons for exclusion from Classification as set out in Section 1.3 has occurred.

Please note that all Forms need to be duly signed by the Applicant.

**3.1 Letter of Application**

The Applicant must duly complete and sign the Letter of Application in the form set out in Form A of Appendix A to this Invitation. The signatory shall be authorized by Power of Attorney. The Power of Attorney shall be authenticated by a notary public or by the consular authorities of the Republic of Lebanon. The Applicant shall attach the duly filled out and the signed Mandatory Statement as set out in Form B of Appendix A.

The Applicant may, to the extent possible, provide third party declarations or certifications for any of the issues listed in the Mandatory Statement.

The Applicant must in its Letter of Application clearly specify whether he is applying for classification as Developer or Consortium Member.

**3.2 Applicant Organization Documents**

Applicant must submit as Section 1 of its Application the following information:

- The Applicant information in Line with Form A of Appendix B of to this Invitation, including the contact data of the Applicant; and
- Applicant organizational structure comprising the information as set out in Form B of Appendix B

**3.3 Technical Capability**

In order to classify, the Applicant must prove its technical capability to act as a Developer or a Consortium Member in accordance to the below.

**3.3.1 Technical Classification Requirement for Developers**

**Developer** for the purpose of this classification means a firm that intends to participate in the development of a conventional power plant project as the Lead Developer, meaning that it will hold the largest share portion in a special purpose company founded for the implementation of a conventional power plant project in Lebanon and acts as the managing member in such special purpose company.

In order to be considered for classification under this Invitation, the Applicant must provide evidence that it has developed conventional power plant projects either as single firm or as lead developer in a consortium (i.e. holding the largest share portion and acting as managing member in the IPP) under BOO, BOOT, DBO, DBOT or similar schemes for at least two conventional power projects with a combined net capacity of minimum 800 MW within the last ten (10) years.

Applicant's references must be provided as part of the Application for Classification in the form set out in Form A of Appendix C to this Invitation.

For purposes of clarity EPC Contractors, O&M Contractors, and Electricity Supply Companies etc. that have provided their service to an IPP Project but have not acted as a Lead Developer, are not eligible to be classified as Lead Developer under this Invitation.

**3.3.2 Classification Requirement for Consortium Member**

Consortium Member for the purposes of this classification means a firm that intends to participate in the development of conventional power projects on IPP basis with an ownership share of less than 50%.

The following entities shall be able to classify as a Consortium Member:

- **Developers:** the Applicant must provide evidence that it has developed conventional power plant projects either as single firm or as lead developer in a consortium (i.e. holding the largest share portion and acting as managing member in the IPP) under BOO, BOOT, DBO, DBOT or similar schemes for at least one conventional power project with a combined net capacity of minimum 300 MW within the last ten (10) years and which has been in successful operation for at least 2 years since then. Applicant's references must be provided in the form set out in Form A of Appendix C to this Invitation.
- **EPC Contractors:** the Applicant shall provide evidence of its experience as an EPC Contractor or as a member of a consortium or joint venture acting as an EPC Main Contractor (i.e. more than 50% share portion in the EPC Consortium). The EPC Contractor must have completed at least one conventional power project with a combined net capacity of 300 MW, that started commercial operation within the past ten (10) years and which has been in successful operation for at least 2 years since then. Applicant's references must be provided in the form set out in Form B of Appendix C to this Invitation.
- **O&M Contractors:** the Applicant shall provide evidence of its experience as an O&M Contractor or if the O&M Contractor is a consortium or joint venture acting as a Main Contractor (i.e. more than 50% share portion in the O&M Consortium). The O&M Contractor must have successfully operated at least one conventional power project with a net combined capacity of 300 MW, that started commercial operation within the past ten (10) years and which has been in successful operation for at least 2 years since then. Applicant's references must be provided in the form set out in Form C of Appendix C to this Invitation.

- **Energy Supply Companies:** the Applicant shall provide evidence that it is holding power generation assets with more than 300 MW combined net capacity in at least two (2) power plants. Applicant's references must be provided in the form set out in Form D of Appendix C to this Invitation.

For purposes of clarity EPC Contractors, O&M Contractors, and Electricity Supply Companies applying under this section are being considered as co-developers and not as EPC contractors or O&M contractors or Electricity Supply Companies that will provide their speciality services to the IPP Project. Further post qualifications will be required in the RFP documents for the provisions of such specific services.

### **3.4 Financial Capability**

All Applicants must provide the necessary information to demonstrate that they will be able to meet the financial requirements associated with the implementation of conventional power Plant Projects as Independent Power Producer.

The Applicant shall provide the financial information for the previous three financial years (2016, 2017 and 2018) as per Appendix D to this Invitation. The financial data shall be provided together with the audited financial statement and annual reports for the corresponding years (including profit & loss statements, balance sheets, cash-flow statements, notes to the accounts, audit reports) and other financial data, which you may consider to be useful.

### **3.5 Other Information**

The Applicant is free to submit any other information it feels would be useful to support its Application in respect to their corporate and organizational structure, technical capabilities and experience, human resources or financial capabilities.
